Notice is hereby given that the Detroit Regional Convention Facility Authority (DRCFA) is soliciting bids for a **Mechanical Refrigeration Equipment and Services** per the terms and conditions of the Request for Proposal (RFP).

Bidders are highly encouraged to attend the pre-bid meeting and site visit on **August 29, 2024 at 11:00 am at Huntington Place Convention Center**, One Washington Blvd, Detroit, MI 48226. Meet in Conference Room 352 on the 3rd floor. Bidders are responsible for understanding the RFP and service requirements prior to the meeting. Bids shall be prepared in accordance with specifications outlined in the RFP. Bid responses shall be on forms furnished by the DRCFA in this RFP. Each Bid Proposal must be accompanied by a certified check, cashier's check, or a satisfactory surety bid bond in an amount not less than five percent (5%) of the total Bid Proposal price as guaranty. Bidders must provide Iran Linked Business disclosure in compliance with Public Act 517 of 2012 and attach this information to the bid proposal. The bid proposal must be accompanied by a sworn and notarized statement that their business is NOT an Iran Linked Business.

A bidder will be permitted to withdraw his bid, unopened, after it has been submitted if so requested prior to the time specified above for opening of bids.

Sealed bid submittals must be received on or before **September 12, 2024 at 2:00 p.m. local time** via mail or delivery to purchasing@drcfa.org or mailed to Detroit Regional Convention Facility Authority, One Washington Blvd, Administrative Offices, Detroit, MI 48226, Attention: Purchasing Department, Ms. Laura Harrington. No allowance will be made for late delivery for any reason. Late bids shall not be opened nor returned to bidder.

Bids will be publicly opened on **September 12, 2024 starting at 2:00 p.m.**, local time, by the DRCFA, at One Washington Blvd, Detroit, MI 48226. Interested parties may join in person in Conference Room 352. RFP evaluation and award subsequently will be made by the Board of Directors at the DRCFA. The successful bidder shall be required to enter a contract with the DRCFA.

The DRCFA reserves the right to reject any or all bid proposals, either in whole or in part, to split the award, to award to other than the low cost bid, to waive any informalities or irregularities, and to accept bid alternates. The DRCFA also reserves the right to award a contract in any manner deemed by the DRCFA, in the DRCFA's sole discretion, to be in DRCFA's best interests.
